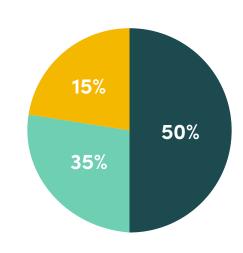

### **Giving Options (Operating Budget)**

#### The Ministry Budget

The Ministry Budget includes all budget line items needed for the day-to-day operation of Broadmoor. This includes individual discipleship ministry budget needs as well as maintenance on our physical facility, personnel salaries and benefits, and operational expenses such as equipment maintenance and replacement, church vehicle maintenance, and internet technology. Consistent with the 2023 Ministry Budget, a portion of the missions budget is contained within the overall 2024 Ministry Budget. We are reserving ten percent of our Ministry Budget in support of the Cooperative Program and Broadmoor Missions. Broadmoor Missions includes support for both Broadmoor's Mission Partners and Global Missions: International (Lottie Moon), North American (Annie Armstrong), and State Missions (Margaret Lackey). 100% of your tithes and offerings go towards the Ministry Budget, unless you specify otherwise.

#### **Missions Partner Support**

Any additional funding for our partners given above your tithes must be designated as "Missions" on your contribution envelope or as designated through online giving. Access to a complete listing of all Broadmoor's Mission Partners can be found online at www.broadmoor.org/missions.

#### **Debt Service and Cash Reserves**

During 2023, Broadmoor remained debt free. In periods in which Broadmoor does not have debt, funds designated for debt service are accounted for as cash reserves. During 2023, Broadmoor received \$220,000 designated for cash reserves.

#### **Special Offerings**

Periodically throughout the year, we will collect special offerings to support initiatives that Broadmoor has identified as a priority. These include Annie Armstrong, Margaret Lackey, Lottie Moon, Shelter Ministry, and Community Care. These special offerings are in addition to the amounts included in the Ministry Budget. 100% of the gifts given for these special offerings are directed to support these initiatives.

## **Operating Cash Reserves**

Over the past several years Broadmoor has been blessed to establish operating reserves for the use of general cash reserves, campus improvements, professional fees, long-term debt paydown and staff bonuses. Broadmoor is currently debt free, and maintains a cash reserve in the operating account to meet obligations throughout the year.
